



The JYB3 Group offers strategic programs in building public, corporate, and government alliances, helping a variety of select clients invest in the future of our Commonwealth.




JOHN Y. BROWN III

John Y. Brown III was born into a family dedicated to serving Kentucky. John's grandfather served in the U.S. Congress under FDR as well as Kentucky's Speaker of the House. His father served as Governor of Kentucky from 1979–1983 after introducing Kentucky Fried Chicken to the world. So it almost seemed inevitable that John would serve the Commonwealth: in 1995 at the age of 32 he was elected as Kentucky's secretary of state and served two highly acclaimed four-year terms. John was the second-youngest secretary of state in the nation and one of Kentucky's youngest statewide officeholders in modern Kentucky history. John ran as the lieutenant governor running mate with then-Speaker of the House Jody Richards in 2007, but came up short in a crowded primary.

John graduated from Bellarmine University, earned a law degree (with distinction) from University of Kentucky, and then went back to Bellarmine for his MBA.

He's taught business and law at the university level, helped launch businesses, created new opportunities for corporations, and serves as a registered lobbyist. The combination of business, government, legal, and academic experience prepared John perfectly for the birth of the JYB3 Group, a firm dedicated to bringing the best of commerce and government together for the common wealth of all Kentuckians.




LAURA EMBERTON OWENS


